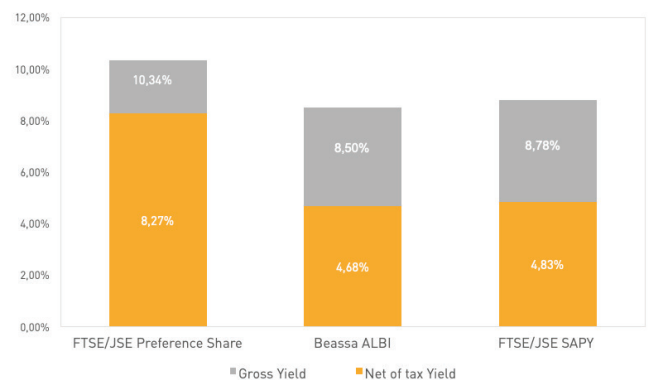

Yield Comparison



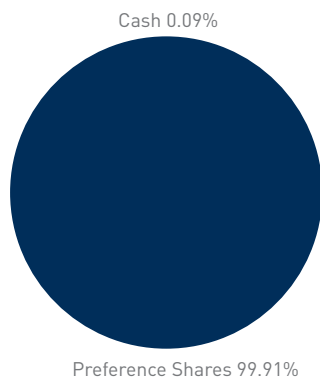
