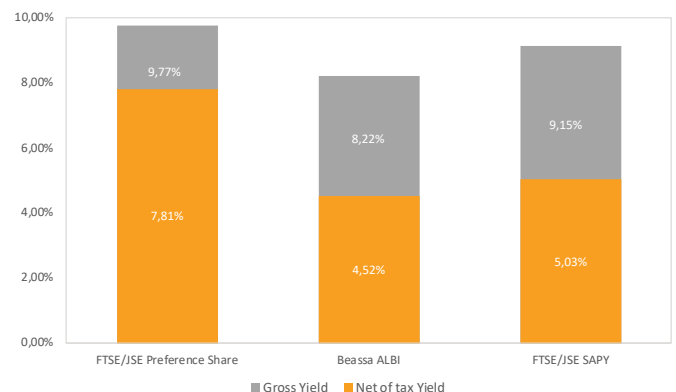

#### Yield Comparison



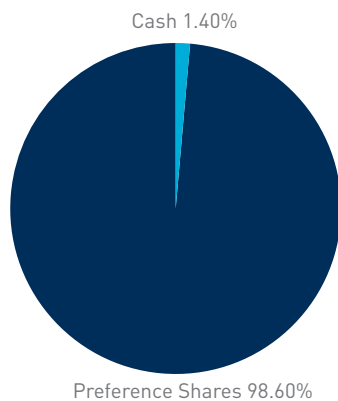
