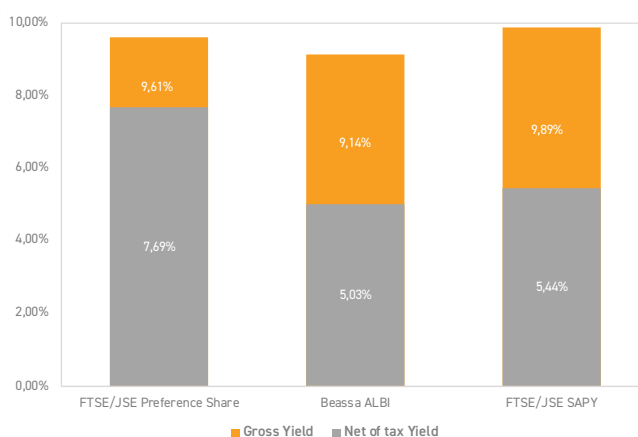

### INCOME ADVANTAGE GRAPH



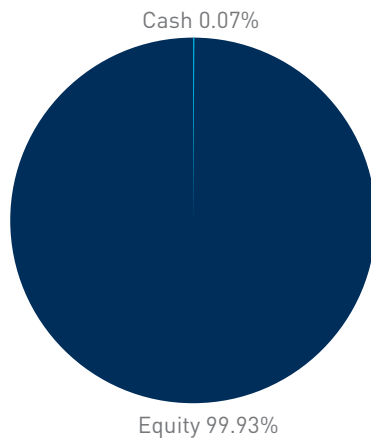
