CoreShares (as defined in the Terms of Use available at [www.CoreShares.co.za](http://www.CoreShares.co.za)) respects your privacy and is committed to keeping your information confidential. This Privacy Policy applies to CoreShares' website and Online Platform and governs the collection, usage and security of information.

## COLLECTION OF INFORMATION

The personal information we collect about you comes primarily from the information and materials you provide and your communications to us in connection with your use of our website and online platform.

## USE OF INFORMATION

Personal information is used as is appropriate in the normal course of business to provide the products and services you have requested. We may retain any information for purposes of investment transaction processing and administration, to monitor our site or to communicate directly with you.

We use "cookies" to make your experience of our website better, a cookie is a small piece of data that a website asks your browser to store on your computer or mobile device. The cookie allows the website to "remember" your actions or preferences over time.

We use cookies to learn how you interact with our content and to improve your experience when visiting our website. For example, some cookies remember your language or preferences so that you do not have to repeatedly make these choices when you visit our website. Additionally, cookies allow us to serve you specific content, such as videos on our website.

You can limit the collection of your information by disabling cookies on your browser, however, our website relies on cookies to enable certain functionalities. If you choose to disable cookies, some of the services available on our website may not work properly.

For some of the functions within our website we use third-party suppliers, for example, when you visit a page with videos embedded from or links to YouTube.
